This role will closely partner with a variety of stakeholders, including Business Performance, NVS brand and functional teams, and all the IDS functional teams.

This position will be located at East Hanover, NJ site and will not have the ability to be located remotely. This position will require 15% travel as defined by the business (domestic and/ or international).

- Collaborate with scrum, development, and support teams for these products, including remote teams located internationally
- Collaborate with brand teams, functional teams (e.g., Medical, NPS, Market Access, Field), IDS teams and other NVS partners
- Collaborate with the Business Performance team to optimize data collection and reporting workflows and

- ensure data integrity and relevance
- Fully leverage GenAl in creation of modern performance reporting interfaces
- Proactively QC all reporting interfaces
