- Participate in the Technology Evaluation for the business / technical solutions ensuring a holistic approach is applied.
- Identify high-level technology solutions to address business demand, ensure globally aligned business capabilities, and drive adoption of global solutions.
- Ensure a retirement/exit strategy exists for business/technology solutions.
- Contribute and ensure adherence to Enterprise standards and architecture Governance (e.g. architecture methods, tools, practices, and standards) for DDIT, supporting the Architecture Governance team / Community of Practice
- Ensure adherence to ISC, Legal, ethics, and other compliance policies and procedures in defining architecture standards, patterns, and solutions.
- Take functional responsibility for supporting and mentoring the solution architects and data modelers to

expand the depth and breadth of skills.

- Ensure Solution Architecture, design, and models are reviewed for Program/Project/Platform Architecture in scope for the respective domain in close collaboration with Product Lines.
- Provide overall architecture leadership to the transformation programs to support the provision of services and solutions for the given domains.
- Support the programs to deliver standardized operating guidelines, design principles, and best practices agreed at the Development and Enterprise levels.
- Enforce a standard technology stack to streamline the development process, enhance interoperability, and support scalability.
- Schedule reviews to assess adherence to guidelines, identify improvement opportunities, and maintain/track cross-program integrations/dependencies.
- Support technology selection activity across the Development and Enterprise levels.
- Accountable for supporting the Development Transformation Programs during delivery to ensure the right architecture decisions are made and we avoid bottlenecks.
