I, Amit K. Trivedi, Company Secretary in Whole-time Practice, have been appointed as Scrutinizer of M/s Novartis India Limited ("the Company") for the purpose of scrutinizing the physical poll paper and e-voting processing fair and transparent manner& ascertaining the requisite majority on e-voting carried out as per the provisions of the Section 108 and Section 109 of the Companies Act, 2013read with Rule 20 and Rule 21 of the Companies (Management and Administration) Rules, 2014on the below mentioned resolution(s), at the Annual General meeting of the Equity Shareholders of Novartis India Limited, held on Friday, 28<sup>th</sup>July, 2017at Hall of Culture, Nehru Centre, Dr. Annie Besant Road, Worli, Mumbai-400018, we submit our combined report as under:

- 3. At the end of the e-voting period, I have unblocked the electronic votes on July 28, 2017, at 12.35 p.m. in the presence of two witnesses not in the employment of the Company.
