By leveraging diverse datasets and advanced statistical techniques, the Director drives strategic thought and effective decision-making, combining data analytics with business functions to uncover valuable insights that clarify both the what (data) and the why (business) behind business decisions. Acting as a strategic partner to NPS and Medical leaders, the Director employs modern market research strategies and methods to address the needs of key stakeholders, ensuring that informed strategies can be developed and implemented in alignment with the organization's strategic objectives.
