

IDENTIFYING PATIENTS WITH IMMUNOGLOBULIN A NEPHROPATHY (IgAN)

INSTRUCTIONS

Oracle Cerner has several reporting tools available to help identify patients with IgAN and assess clinical factors of these patients, such as degree of proteinuria, presence and degree of hematuria, serum creatinine, and estimated glomerular filtration rate (eGFR). A Dynamic Work List or Discern Analytics 2 (DA2) report are reporting tool options and may be used to create this patient query.

The inclusion criteria are:

- International Classification of Diseases, 10th Revision (ICD-10): N02.B*
*Includes child codes N02.B-B9
- Lab Components: proteinuria, hematuria (found in fresh urinalysis sample), serum creatinine, eGFR

OPTION 1:

Dynamic Work List

1. Select **Dynamic Work List** from the menu. The **Dynamic Work List** wizard will display
2. Select **Create Work List** from the **List Actions** drop-down menu
3. The **Create New Work List** wizard contains three tabs:
 1. **Work List Type**; 2. **Criteria**; and 3. **Summary**
 1. **Work List Type**
 - a. Enter a name in the **Name Your Work List** to define the patient list (eg, IgAN Patients_Dr ABC)
 - b. Select the radio button for **Group/Provider** or **Location** as desired and complete the **Group/Provider's Relationship Type** or the **Location's Facility, Building, and Unit**
 - c. In the **Relationship Type**, select all desired roles (for example, Primary Care Physician, Nurse Practitioner, etc). This may vary based on how the electronic health record (EHR) was set up
 - d. Click **Next**
 2. **Criteria**
 - a. Click on the **Conditions** criteria
 - b. Set the operator logic to **AND**
 - c. Select **IgAN Condition D**
 - d. Set the desired **Look-back Range** (for example, 1 year)
 3. **Summary**
 - a. Review the selected criteria and click **Finish** to run the patient list
 - b. The names of patients will display. Clicking on the **List Actions** drop-down menu allows you to export the list of patients to Excel by clicking **Export**

Note: If IgAN Conditions in Step 2. Criteria are not available, they may be created or modified in the **Bedrock Wizard** (Care Management under the Solutions column). Double-click **Registry** and **Conditions Set Set-up**. Click **Add** to create a new Condition Set or modify an existing Condition Set and enter a unique name for the Condition Set and move all desired conditions. Click **Save** to complete the build process.

Optional:

Patients can be reached by clicking **Generate Communication**. A new window will open, where a letter template can be created and sent to the patient.

OPTION 2:

DA2

1. Launch **Discern Analytics 2.0**. It may be found as **DA2.exe** in the Cerner applications folder
2. Click the **Domains** tab to access available domains
3. Select **File > New > Query** or select the desired domain by double-clicking it
4. The query wizard will display available categories
5. In the **Qualifications** window, select the **Diagnosis Code Filter** and click **Modify Filter List**
6. Type **N02.B-B9*** in the search box and select the desired ICD-10 codes (**N02.B, N02.B1, N02.B2, N02.B3, N02.B4, N02.B5, N02.B6, N02.B7, N02.B8, N02.B9**).
Click **Include**
7. Select all the desired columns to include in the report by clicking the right arrow or dragging the selected folders to the **Columns** window (eg, First Name, Last Name, Primary Care Physician, Diagnoses, etc)
 - a. Consider a column that uses the **Date** and **Date/Time** qualifications to set the look-back period
8. Set the general criteria for the report (name, version, time-out range, etc) and save the query
9. Click **Query > Query review** or **Run Query** in **Viewer** in the **Query** tab to run the query
10. The results will display. Export to Excel for further manipulation of data

Optional:

Patients can be reached by clicking **Generate Communication**. A new window will open, where a letter template can be created and sent to the patient.
